

PRIVACY POLICY

At Corridy Property we are committed to protecting your privacy. This Privacy Policy covers the collection, use and disclosure of personal information that we collect from you on this site or through our network. The information we hold is the minimum required by us and any associated companies to provide you with the services, quotes or information that you have requested or may require.

By submitting your personal data to us, you will be treated as having given your permission for the disclosures referred to in this Policy.

1. Your personal information and how Corridy manages this

For the purpose of the Data Protection Act 1998, the data controller is Corridy Property Management Limited whose registered address is 37 Vicarage Road, London SW14 8RZ. Under the Data Protection Act, you have a right to be told what personal data we hold about you. If you would like to see this data then please contact us as set out below.

We collect and use personal information (such as your name, address, telephone number and email) in order to respond to any queries or requests you may have; administer or otherwise carry out our obligations in relation to any agreement we may have; anticipate and resolve problems with any goods or services supplied to you; and arrange for products or services that may meet your needs.

Except as set out in this privacy policy, we will not disclose any personally identifiable information without your express permission unless we are legally entitled or required to do so. This may be for the purposes of fraud prevention or if required to do so by legal process.

When you provide us with your personal information and you request a service which requires contact from us, we or our representatives may use it to inform you of the requested information.

2. The use of cookies

We may automatically collect non-personal information about you such as the type of internet browsers you use or the web site from which you linked to our site. You cannot be identified from this information and it is only used to assist us in providing an effective service on this web site.

When visiting and then returning to our site, we may store some information (referred to as "cookies") on your computer. The type of information we collect as a result of a cookie being accepted by you includes the IP address, the date and time the PC visited the website, what parts of our website were looked at and whether the web pages requested were delivered successfully. This information is anonymous; it represents a computer rather than a person. We use the cookie information to understand how our website is used, which enables us to improve the service we provide. You can erase or block this information by changing the settings on your computer (please refer to your help screens or manuals). If you do erase or block this information you may not be able to utilise some features of our site.
